  - (i) the Report of the Eighth Meeting of the Scientific and Technical Advisory Committee (STAC-8) (WP 4.1).
  - (ii) the Report of the Seventh Meeting of the Steering Committee of the Pacific Regional Center for Training and Technology Transfer for the joint implementation of the Basel and Waigani Conventions (SCPRC-7) (WP 4.2).
  - (iii) The Report on Status of Actions Taken on the Implementation of the 2019-2020 Business Plan (WP 4.3).

## **Background**

# **Eighth Meeting of the Scientific and Technical Advisory Committee (STAC-8)**

- The Conference of Parties to the Waigani Convention at its first meeting (COP1) decided to
  establish a Scientific and Technical Advisory Committee (STAC) to meet as necessary
  subject to available resources, to fulfil its tasks as mandated by the COP.
- 3. At its second meeting (COP2), the Conference considered and approved the Terms of Reference for the STAC.
- 4. The committee has since met eight times since its establishment in 2002 the first meeting in 2004 and the Eighth meeting in June 2021. All the meetings have been held in person except for the Eighth meeting which was held virtually due to the COVID-19 global pandemic.

# Seventh Meeting of the Steering Committee of the Pacific Regional Center (SCPRC-7)

 The Pacific Regional Centre (PRC) was established by way of a Memorandum of Understanding (MOU) in 2003 between the Secretariats of the Waigani and Basel Conventions on behalf of their respective Parties.

- 6. Article VII of the MOU provided for the establishment of a Steering Committee to advise on the development and implementation of the activities of the Centre and to enhance national support to its work form countries served by the Centre.
- 7. The SCPRC has met seven times since its establishment in 2006 the first meeting of the SCPRC was held in 2008 and the seventh in 2019. All SCPRC meetings have been held in person except for the seventh meeting which was held virtually due to the COVID-19 global pandemic.

## Report on Status of Actions taken on the Implementation of the 2019-2020 Business Plan

- 8. In accordance with the MOU that established the PRC, the Secretariat is required to prepare a Business Plan and report on its implementation to the COP.
- Due to the close interlinkages between the Basel and Waigani Conventions, the Business Plan of PRC is embedded into the Hazardous Waste Management Programme (HWMP) of the Secretariat.
- The report presented here therefore captures the progress of the Secretariat's work under HWMP and supporting projects.
