1. Background

- 1.1. The Secretariat of the Pacific Regional Environment Programme (SPREP) is an intergovernmental organisation charged with promoting cooperation among Pacific islands countries and territories to protect and improve their environment and ensure sustainable development.

2. Specifications: statement of requirement

2.1. SPREP would like to call for tenders from registered Insurance Companies who can offer their services to provide annual insurance cover for SPREP's buildings and contents for one (1) year with a possible one (1) year renewal.

3. Conditions: information for applicants

- 3.1. To be considered for this tender, interested suppliers must meet the following conditions;
 - I. Legally registered as an insurance provider
 - II. Proven ability/history of service in the insurance market

4. Submission guidelines

- 4.1. Tender documentation should demonstrate that the interested supplier satisfies the conditions stated above and is capable of meeting the specifications and timeframes. Documentation must also include supporting examples to address the evaluation criteria. Describe any additional minimum content and format requirements.
- 4.2. Tender documentation should outline the interested supplier's complete proposal: methods, personnel (and their skill sets/curricula vitae), timeframes and costs.
- 4.3 Tenderers/Bidders must insist on an acknowledgement of receipt of tenders/proposals/bids.

5. Tender Clarification

A summary of all questions received with an associated response will be posted on the SPREP website www.sprep.org/tender by 25 July 2018.

6. Evaluation criteria

- 6.1. SPREP will select a preferred supplier on the basis of SPREP's evaluation of the extent to which the documentation demonstrates that the tenderer offers the best value for money, and that the tenderer satisfies the following criteria.
 - 6.1.1 Building contents sum insured under replacement value
 - 6.1.2 Building contents sum insured under current indemnity value
 - 6.1.3 Total annual premium for 6.1.1 and 6.1.2 for the period September 2018 September 2020
 - 6.1.4 Excess
 - 6.1.5 Scope of cover
 - 6.1.6 Other claims
