Subject: Request for tenders: RMI Battler Vehicle

1. Background

- 1.1. The Secretariat of the Pacific Regional Environment Programme (SPREP) is an intergovernmental organisation charged with promoting cooperation among Pacific islands countries and territories to protect and improve their environment and ensure sustainable development.
- 1.2. SPREP approaches the environmental challenges faced by the Pacific guided by four simple Values. These values guide all aspects of our work:

 - We value high quality and targeted Service Delivery

2. Specifications: statement of requirement

- 2.1. SPREP would like to call for tenders from suppliers who can supply and deliver a new compact sports utility vehicle to the Republic of Marshall Islands.
- 2.2. The successful applicant will need to provide and deliver the vehicle and accessories as per the attached specification to RMI by 15 July 2020.
- 2.3. The Tender Evaluation Process will consider the ability of suppliers to provide after sales services to assist with maintenance of the vehicle.

3. Conditions: information for applicants

- 3.1. To be considered for this tender, interested suppliers must meet the following conditions:
 - i. Have a current valid business license
 - ii. Must be an authorized agent or car dealer based in Majuro.

4. Submission guidelines

- 4.1. Tender documentation should demonstrate that the interested supplier satisfies the conditions stated above and can meet the specifications and timeframes. Documentation must also include supporting examples to address the evaluation criteria:
- 4.2. Tender documentation should outline the interested supplier's complete proposal: methods, timeframes and costs.
 - i. Financial proposal must include the breakdown of costs





- a) including freight to RMI
- ii. Delivery time frame
- iii. Three (3) references
- 4.3 Tenderers/Bidders must insist on an acknowledgement of receipt of tenders/proposals/bids.
- 4.4 This procurement is exempt from any sales, excise tax and import duty. Suppliers are asked to provide prices that exclude these taxes.

5. Tender Clarification

6. Evaluation criteria

- 6.1 SPREP will select a preferred supplier on the basis of SPREP's evaluation of the extent to which the documentation demonstrates that the tenderer offers the best value for money, and that the tenderer satisfies the following criteria:
 - i. All of the requirements, as detailed in the attached specification are met (30%)
 - ii. The supplier has demonstrated experience in the supply and delivery of vehicles into the Pacific and an ability to provide after sale support to assist with maintenance (30%)
 - iii. Delivery of vehicle to RMI is within delivery time frame of 15 July 2020 (20%)
 - iv. Financial proposal must include the breakdown of costs including freight to RMI (20%)

7. Deadline

- 7.1. The due date for submission of the tender is: 30 June 2020, midnight (Apia, Samoa local time).
- 7.2. Late submissions will be returned unopened to the sender.
