# A. Background Information on SPREP

The *Secretariat of the Pacific Region Environment Programme* (SPREP) is the regional organisation established by the Governments and Administrations of the Pacific charged with protecting and managing the environment and natural resources of the Pacific.

The head office is based in Apia, Samoa with other SPREP offices in Fiji, the Republic of the Marshalls Islands and Vanuatu.

SPREP has around 150 staff and has an annual budget of approximately USD35 million in 2022.

The establishment of SPREP in 1993 sends a clear signal to the global community of the deep commitment of Pacific island Governments and Administrations for better management of the environment within the context of sustainable development.

The strategic direction for SPREP is clearly set out in the 2017-2026 SPREP Strategic Plan. The Plan outlines the mandate, vision and programmes for the organisation, and places strong emphasis on effective delivery of services to SPREP Member countries and territories.

### Mandate

SPREP's **mandate** is to promote cooperation in the Pacific region and provide assistance to Pacific island countries and territories in order to protect and improve its environment and to ensure sustainable development for present and future generations.

### Vision

SPREP is guided by its vision for the future:

"A resilient Pacific environment, sustaining our livelihoods and natural heritage in harmony with our cultures".

# B. EDF-11 Pacific-European Union Marine Programme (PEUMP)

SPREP is implementing the By-catch and Integrated Ecosystem Management (BIEM) Initiaitve which is Key result Area 5 of the Pacific-European Union Marine (PEUMP) programme. Funded by the European Union and the Government of Sweden, the EUR 45 million PEUMP programme has recently been extended to April 2025. The programme promotes sustainable management and sound ocean governance for food security and economic growth, while addressing climate change resilience and conservation of marine biodiversity. It follows a comprehensive approach, integrating issues related to oceanic fisheries, coastal fisheries, community development,

marine conservation and capacity building under one single regional action.

The PEUMP programme focuses on equitable benefits for all Pacific countries, whilst recognising the diversity of resources, needs and opportunities amongst its 15 Pacific countries of work - the Cook Islands, Fiji, Federated States of Micronesia (FSM), Kiribati, Nauru, Niue, Palau, Papua New Guinea, Republic of the Marshall Islands, Tuvalu, Tonga, Samoa, Solomon Islands, Timor Leste and Vanuatu.

Several key Pacific regional agencies are also part of the PEUMP programme, with targeted support being implemented by the Pacific Community (SPC), Forum Fisheries Agency (FFA), Secretariat of the Pacific Regional Environment Programme (SPREP) and University of the South Pacific (USP) in close collaboration with national authorities and Non-Government Organisations such as the Locally Managed Marine Area (LMMA) Network, Worldwide Fund for Nature (WWF), International Union for the Conservation of Nature (IUCN) and the Pacific Islands Tuna Industry Association (PITIA).

These multi-stakeholder partnerships collaborate, lead and deliver targeted programme support through:

- 1. Partnerships with Pacific Island countries to reduce illegal, unregulated and unreported (IUU) fishing activity and increase national capacities for sustainable management **(SDG 14.4)**;
- 2. Partnerships with the Private Sector to create new business opportunities, to improve legal practices and to foster decent employment creation (SDG 14.7);
- 3. Partnerships with NGOs to increase awareness on IUU fishing activities and support advocacy campaigns for behaviour changes (SDG 14.4);
- 4. Promotion of the sustainable utilisation of coastal and marine biodiversity through improving marine spatial planning, climate change resilience, and conservation **(SDG 14.2)**;
- 5. Capacity building involving the regional university network and TVET institutions as a key tool for better fisheries and marine resources management (SDG 4);
- 6. An annual Policy Dialogue on integrated ocean governance and sustainable fisheries between the EU and Pacific Island Countries is a key initiative to promote accountability in the management of marine resources, enhance understanding on joint priorities, and strengthen the voice of stakeholders (SDG 17);
- 7. Gender mainstreaming and human rights-based approaches as key pillars to promote direct opportunities and positive changes for Pacific Island people., targeting women, men, youth and vulnerable groups (SDGs 5 and 10).

8. Facilitation of sector policy dialogues involving civil society organisations and non-state actors, including the private sector, further contributing to ownership and sustainability beyond the life of the programme (SDG 17).

The BIEM Initiative is focused on the sustainable utilisation of coastal and marine biodiversity promoted through improving marine spatial planning, increasing climate change resilience, enhancing conservation, mitigation and rehabilitation measures. To achieve the result, SPREP is delivering specific activities with regional organisations, national governments and local communities under-pinned by gender and human rights-based approaches to halt the decline of protected marine species, strengthen the sustainable management of coastal and marine ecosystems and support poverty reduction.

Specifically, the BIEM Initiative is focused on:

- 1. Supporting marine spatial planning in Fiji and the Solomon Islands
- 2. Integrated ridge to reef ecosystem management and climate change adaptation in Fiji and Vanuatu
- 3. Assessment of marine turtle extinction risk and the status of cetaceans in the Western Central Pacific Ocean
- 4. Development and implementation of bycatch mitigation strategies
- 5. Capacity development through research grants to Pacific Island Citizens
- 6. Support for community monitoring and protection of endangered species
- 7. Capacity building on non-detrimental findings process for Convention of International Trade of Endangered Species (CITES) parties.

BIEM Initiative activities are designed to be relevant to all Pacific countries. However, to maximise the positive impact of the work with the funding available the majority of work is being undertaken in Fiji, Papua New Guinea, Solomon Islands, Tonga and Vanuatu.



Excellent knowledge of emerging project-related environmental issues and challenges facing the Pacific region with excellent understanding and appreciation of environmental ethics, values and priorities as well as comprehensive knowledge and experience in waste management and pollution control, preferably within the Pacific islands region.
- 4. Excellent relationship management and fundraising skills and experience that demonstrate a high level of professional and constructive engagement with a diverse range of stakeholders as well as an excellent understanding of key donor partners (especially the European Union) and funding institutions with proven fundraising experience
- 5. Excellent project management and leadership experience including the development of funding proposals, design and delivery of integrated work programme activities, monitoring and evaluation of performance, resource management as well as a good understanding of synergies and interlinkages across multilateral environmental agreements

- 6. Excellent leadership and management experience including high level advisory and analytical skills as well as leading and nurturing teams of diverse technical backgrounds and expertise in multicultural and multi-disciplinary environments
- 7. Excellent experience at strategic and high-level communication, negotiation and reporting across diverse audiences, as well as extensive experience in capacity building, particularly in the Pacific setting

# C. REMUNERATION PACKAGE – TERMS & CONDITIONS

**Duty Station**: The position will ideally be based in Suva, Fiji, with consideration given to applications to be based in Port Vila, Vanuatu or Apia, Samoa.

**Duration**: Appointment is for a term of 28 months initially with possible renewal if the European Union approve a second phase of the PEUMP programme, subject to performance during the initial term, continuity of related project activities and availability of funds.

**Salary**: Salary is denominated in International Monetary Fund Special Drawing Rights (SDRs). Remuneration for this post falls within Band 12 of SPREP's salary scale. Starting salary will be SDR41,822. Currently, the equivalent is USD66,502 per annum. Upon confirmation of probation, salary will be adjusted to USD74,814 per annum. All positions have been evaluated to reflect the level of responsibilities and level of experience and qualifications required.

# The following terms and conditions are based on location of the position in Suva, Fiji. These will be adjusted to reflect location specific rates if the position is based in Port Vila, Vanuatu or Apia, Samoa.

**Adjustments**: Salaries and allowances for internationally recruited staff are paid in Samoan Tala and adjusted every month based on the monthly average in the value of the SDR relative to the Samoan Tala (SAT) at the time the salary payment is processed. SDR movement however is limited to within 5% above or below a reference point set annually. Remuneration is paid monthly in SAT equivalent. The international currency exchange rate at the time of writing is approximately USD1.00 = SAT\$2.40

**Term**: For staff recruited from outside Fiji, the term begins from the day the appointee leaves their home to take up the appointment. Appointment is subject to a satisfactory medical examination including full vaccination against COVID-19 and a clean police report, as well as a 6-month probationary period.

An appointment is terminated by (i) completion of term of contract (ii) one month's notice by either party (iii) without notice by either party paying one month salary in lieu of notice or (iv) dismissed with or without notice as a disciplinary measure.

**Performance Reviews**: Annual performance assessments and performance rewards will be based on the Secretariat's Performance Development System.

#### FOR STAFF RECRUITED FROM OUTSIDE FIJI, THE FOLLOWING APPLIES:

**Relocation Expenses**: SPREP will meet certain appointment and termination expenses for staff recruited from outside Fiji, including transport and accommodation en-route for the appointee and accompanying dependant(s) between point of recruitment and Suva, and return, by the shortest and most economical route. This includes:

- economy class airfares;
- reasonable cost of packing, insuring, shipping and transporting furniture, household and personal effects on a 20ft container; and,

• up to 20 kilos of excess baggage each for the appointee and family.

**Establishment Grant**: A lump sum of SDR2,500 is payable upon taking up appointment and arrival in Apia. This is currently equivalent to USD3,975.

**Temporary Accommodation and Assistance**: On arrival in Suva, the appointee and dependent(s) are entitled to temporary accommodation at a suitable hotel or other fully furnished accommodation for up to 6 working days. The appointee will be assisted to settle into Suva. This will include help in finding suitable rental accommodation.

**Privileges and Immunities**: SPREP remuneration is tax-free for non-citizens or non-residents of Fiji, including duty-free importation of household and personal effects which have been owned and used by them for no less than six months, within 6 months of taking up appointment.

**Repatriation allowance:** The appointee is entitled to a repatriation allowance equivalent to two week's salary, upon successful completion of contract, provided the contract is not extended or renewed.

#### FOR ALL INTERNATIONALLY RECRUITED STAFF, THE FOLLOWING APPLIES:

**Education Allowanc**e: Education expenses maybe reimbursed against actual receipts for dependent children, to cover up to 75% of the actual costs, as stipulated under SPREP's Education Allowance policy. Currently the allowance is up to a maximum of USD6,500 per annum per dependent child, with an overall maximum of USD19,500 per annum per family of 3 or more eligible children.

**School Holiday Travel**: One return economy class flight each year between the place of education (taken to be recognised home) and Suva by (i) each dependent child being educated outside Fiji or (ii) the staff member or spouse to visit the child, providing the journey is not made within the final 6 months of the contract.

**Family Leave Travel**: Return economy class airfares between Suva and the recognised home for the staff member and dependents after completing 18 months of service for 3-year contracts providing no travel is undertaken within the final 12 months of the contract.

**Housing Assistance**: Internationally recruited staff shall receive housing assistance of 75% of the typical rent payable in Fiji for expatriate executive furnished housing. The current rate is USD1,393 per month. This assistance shall be reviewed annually and adjusted on relative movement in the local rental market.

**Security Assistance:** Security-related expenses maybe reimbursed against actual receipts up to USD1,000 per annum as stipulated under SPREP's Security Assistance policy.

Annual Leave: 25 working days a year (up to a maximum accumulation of 50 days).

**Sick Leave:** 30 working days a year (up to a maximum accumulation of 90 days).

**Other Leave**: Provisions also exist for maternity, compassionate, paternity, examination and special leave (without pay).

Duty Travel: SPREP meets travelling expenses at prescribed rates necessarily incurred by staff

required to travel away from Suva on official business.

**Life and Accidental Death and Disability Insurance**: All employees are covered by SPREP's 24 hour Life and Accidental Death and Disability Insurance Policy.

**Medical Benefits**: All employees and their dependents are entitled to have all reasonable medical, dental and optical expenses met, under the terms and conditions of the existing SPREP Medical Insurance.

**Superannuation**: All employees are required to contribute to a recognised Superannuation Fund. An expatriate internationally recruited staff member has the option to participate in the local Superannuation Fund or nominate another recognised Fund for their superannuation. SPREP will pay the minimum legal requirement of basic salary to the approved nominated Fund. For Fiji, this is currently 5%.

#### Learning and Development

Learning and development opportunities will be based on the approved SPREP Performance Development System and individual Performance Development Plans.

#### Definitions:

'Dependent' means the spouse and financially dependent children of an employee.

'Dependent child' means an employee's unmarried, financially dependent, natural or legally adopted child who is:

- under the age of 16 years; or
- under the age of 19 years if undertaking full-time study at a secondary school; or
- under the age of 25 years if enrolled and undertaking full-time study at a university or other tertiary institution; or
- mentally or physically incapacitated.

'Expatriate' means an internationally recruited staff member, who is not a citizen or permanent resident of Fiji, and who resides in Fiji only by virtue of employment with SPREP.

**Equal Opportunities**: SPREP is an Equal Opportunity Employer. Men and women are equally eligible for all posts in SPREP.
